The final Minimum Data Set (MDS) 3.0 Resident Assessment Instrument (RAI) User's Manual version (v)1.19.1 is now available in the **Downloads** section on the <u>Minimum Data Set (MDS) 3.0</u> <u>Resident Assessment Instrument</u> (RAI) Manual page. The MDS 3.0 RAI User's Manual v1.19.1 will be effective beginning October 1, 2024.

This version of the *MDS 3.0 RAI User's Manual* contains guidance to support the addition of new items N0415K: Anticonvulsant and O0350: Resident's COVID-19 vaccination is up to date.

Additionally, the Discharge Goals column in items GG0130: Self-Care and GG0170: Mobility has been removed; and the guidance and examples in Section GG have been revised to reflect the modification. Expanded guidance has been added regarding Manual Assessment Correction/Deletion Requests in Chapter 3, Section X, and Chapter 5. Various minor alignments, clarifications, and corrections have been implemented throughout; specifics can be found in the included chapter/section change tables following the guidance.

SNF Quality Measures Data

July 2024: CMS updated skilled nursing facility quality measures data. With the October 2024 refresh, these measures will no longer show in the datasets routinely updated for public reporting:

- Percentage of SNF residents whose functional abilities were assessed and functional goals were included in their treatment plan
- Change in residents' ability to care for themselves
- · Change in residents' ability to move around

Once removed, the historic publicly reported measures data will be available in the <u>Nursing homes</u> including rehab services archived data snapshots.

MDS 3.0 QM User's Manual Version 16.0 Risk Adjustment Appendix File – Now Available

The Minimum Data Set (MDS) 3.0 Quality Measures (QM) User's Manual v16.0 Risk Adjustment Appendix is now available. The Risk Adjustment Appendix File for the MDS 3.0 Quality Measures User's Manual is a reference to be used in conjunction with the MDS 3.0 Quality Measures User's Manual v16.0, and contains coefficient values used to calculate the risk-adjusted quality measures. The latest coefficient values in this appendix file utilize assessment data received for 2024 Quarter 1, and reflect, where applicable, updates to the measure specifications for the risk-adjusted NHQI measures, effective October 1, 2023.

PDPM Grouper to Support XML Input

July 23, 2024 - Currently, the PDPM Grouper processes the MDS assessment in a fixed-length string format. To allow for future flexibility, the fiscal year 2025 release of the PDPM Grouper, effective October 1, 2024, will also support MDS assessments in XML format. The XML format will be the one used for submission of assessments to iQIES and defined in the Downloads section below.

Skilled nursing facilities and their software vendors may continue to use the fixed-length string format or they can convert to using the XML format at any time after October 1, 2024, if that better serves their business needs.

Fiscal Year 2025 Skilled Nursing Facility Prospective Payment System Final Rule (CMS 1802-F)

On July 31, 2024, the Centers for Medicare & Medicaid Services (CMS) issued a final rule updating Medicare payment policies and rates for skilled nursing facilities under the Skilled Nursing Facility Prospective Payment System (SNF PPS) for fiscal year (FY) 2025. CMS is publishing this final rule that is consistent with the legal requirement to update Medicare payment policies for SNFs annually. This fact sheet discusses the major provisions of the final rule.

June 2024 Quarterly Confidential Feedback Reports for the fiscal year (FY) 2025 Skilled Nursing Facility Value-Based Purchasing (SNF VBP) Program Now Available

To download the June 2024 Quarterly Confidential Feedback Reports for FY 2025 SNF VBP Program visit the *Internet Quality Improvement and Evaluation System (iQIES)* website. These reports contain facility and stay-level data for the SNF 30-Day All-Cause Readmission Measure (SNFRM) for FY 2023, the FY 2025 SNF VBP Program performance period. These results will be used for the FY 2025 SNF VBP Program year scoring and incentive payment calculations that will take effect October 1, 2024.

- 4. Here you can see the list of reports available for download.
 - Locate the desired SNF VBP Program Quarterly Confidential Feedback Report.
- 5. Select More next to your desired SNF VBP Program Quarterly Confidential Feedback Report and the report will be downloaded through your browser.
 - Once downloaded, open the file to view your facility's report.
